4 Simple Things YOU Can Do to Protect Your Lake.

- 1. Use Phosphorus Free Fertilizer
- Most turf grass does NOT need more phosphorus. Grass needs mostly nitrogen for green growth. The 2nd number on a fertilizer bag shows the % P...it should be "0". P-free fertilizer is widely available...or you can ask for it at your local garden center.
- 2. Do NOT apply fertilizer down to the water's edge. Leave at least a 10-foot wide unfertilized strip – any closer and you may as well fertilize the lake! Fertilizer will migrate to make this unfertilized strip green.
- 3. Don't blow grass clippings or rake leaves into the lake. Grass and leaves contain nitrogen and phosphorus - - nutrients that stimulate algae growth. Grass clippings and leaves consume oxygen from the water as they decompose. Grass clippings and leaves build up organic muck on the lake bottom. Leaves and grass clippings also clog the

4. Plant Only NATIVE Plants in Your Lakeshore Property. Many non-natives, while attractive, can be invasive. Invasive, non-native plants can crowd out beneficial native plants. Non-native plants don't provide necessary habitat for native animals and birds. Control of non-native species is one of the most serious problems in lakes and streams.

REMINDERS

- **★** Inoperable Vehicles It is a violation of the Village Ordinance to park or store a vehicle which is inoperable or unlicensed in residential driveways.
- ★ Clear Paths As a courtesy to Village residents and guests, property owners are required to trim trees and shrubs that extend into the sidewalks and streets. People should be able to walk on the sidewalks without bumping into them.
- **★** Building Permits If you are unsure whether or not your project requires a building permit, please call the Village Hall for confirmation. Some projects that you may not know need permits include:
- Hot water heater replacement
- Air conditioning unit replacement
- Furnace replacement
- Interior remodeling
- ★ Overnight Parking There is no parking on Village streets between the hours of 2:00 am and 7:00 am. If you need to leave a car on the street overnight, you must call or email the Village Hall by 2:00 am. Leave a message including your name, address & the vehicle (s) license plate number (s). *** PLEASE DO NOT FORGET TO LEAVE THE LICENSE PLATE NUMBER (S)***

★ Pets and Pet Waste - Pets are not permitted to roam the Village freely. All pets are ~) /

required to be leashed when not on the owner's property. Allowing your dog to deposit waste on another resident's property or on Village sidewalks or streets and not picking up the waste is a violation of our Village Ordinance.

★ Trash & Yard Waste - Waste Management Guidelines:

All waste materials must be placed out at the curb for collection by 6:00am the day of your collection, but not before 5:00pm the day before your pick-up. This includes yard waste bags and containers. All containers and any solid waste materials that are not collected must be removed from the curb by 8:00am the day after your scheduled collection. There is a 4 bag limit on yard waste bags per week. Landscape waste collection runs from April 15 - November 30 on your scheduled pickup day. Landscape waste includes grass clippings, brush, weeds, leaves, garden and household organic plant material and branches of certain sizes. Landscape waste like Christmas wreaths, pumpkins and other fruits and vegetables should be disposed of as trash. Yard waste and grass clippings must be placed in biodegradable Kraft paper bags/cans (maximum 32 gal. and 50 lbs.) for collection. Yard waste placed in plastic bags will not be collected. Residents are limited to 4 bags or cans of yard waste per week. Addition bags/cans require a call to Waste Management at 800.796.9696 to schedule a pre-paid pickup per bag. Brush must be bundled and tied with biodegradeable twine or string in distinct piles that are no longer than 4 feet in length, 2 feet in diameter and weighing no more than 50 lbs. with no individual branch being greater than 3 inches in diameter.

Fresh Produce Available

Each summer, teens from low-income communities work at the Green Youth Farm in Lake County to grow produce while gaining paid work experience, entrepreneurial skills and exposure to healthy foods and cooking. This program is a partnership between the Lake County Forest Preserves, the Preservation Foundation and the Chicago Botanic Garden.

Fresh produce is available for purchase at a weekly farm stand:

Wednesdays, 9 am-1 pm, from July 11-October 17

The farm stand is located in the parking lot of the Greenbelt Cultural Center, at 1215 N. Green Bay Road, North Chicago.

GREEN YOUTH FARM:

On a 1.25-acre farm nestled within Greenbelt Forest Preserve in North Chicago, the Green Youth Farm in Lake County is providing high school students with a paid work experience, entrepreneurial and job skills train-

ing, guidance by adult mentors, and exposure to healthy foods and cooking, while providing the local food desert community with organically grown produce for free or at a reduced-cost.

The Preservation Foundation partners with the Lake County Forest Preserves and the Chicago Botanic Garden to make this exemplary program possible.

Each summer, 20 students are hired to plan, sow, tend and harvest a 1.25-acre sustainable farm. Participants learn to enjoy and prepare new foods, market their produce at area farmers markets, and provide affordable produce to Lake County's food -insecure residents through weekly farm stands and demonstrations at local Women and Infant Children (WIC) centers. Since the program began in 2003, the Green Youth Farm in Lake County has:

- Employed and mentored nearly 600 students from diverse backgrounds.
- Sold or donated more than 87,000 pounds of produce.

• Conducted food preparation demonstrations at WIC centers, providing 5,098 produce servings to parents and children in 2015 alone.

The Green Youth Farm in Lake County—made possible thanks to donors from across the region—has grown into the model for youth development programs throughout Chicago. Join us as we further the Forest Preserves' mission to provide interactive education for generations to come.



WATERCRAFT STICKERS/REGISTRATION

Get your boat stickers and keys starting April 1st. Every watercraft must have both a state registration sticker and a Village sticker. In order to purchase a Village sticker, **vou must have a** valid current state registration on file with the Village. If you purchase a new boat, a processed application for state registration from the DNR will be accepted for this year. The Village has past years' registrations on file. If you are unsure of your status, please call the Village Hall. Boat stickers will not be issued without one of these documents. Village boat launch (in Sunshine Subdivision) keys may also be purchased at the Village Hall or through the mail. To order by mail, send a check payable to the Village of Third Lake for the appropriate amount, a copy of current state registration, and a list of your watercraft by type and state registration numbers. It's the Law!

All Persons born after January 1, 1998 are required by Illinois State Law to take and pass a boating safety course validated by the Illinois Department of Natural Resources and hold a valid boating safety certificate before they can operate a motorboat with an engine over 10 Horsepower. THIS INCLUDES PERSONAL WATER CRAFT!

 \approx Persons at least 12 years of age and less than 18 years of age may operate a motorboat with over 10 horsepower only if they are accompanied on the motorboat and under the direct control of a parent or guardian or a person at least 18 years of age designated by a parent or guardian, or the motorboat operator is in possession of a Boating Safety Certificate issued by the Department of Natural Resources, Division of Law enforcement,
