ORDINANCE NUMBER 91-07-02

AN ORDINANCE PROHIBITING DISCHARGE OF FIREARMS

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF THIRD LAKE, LAKE COUNTY, ILLINOIS, as follows:

<u>SECTION I.</u> Any person not lawfully authorized to bear arms in the discharge of his duty shall not discharge any firearm in the Village. No person shall kill or wound, or attempt to kill or wound, by the use of firearms, slingshot, bow and arrow, pelting with a stone or otherwise, any animal of any species, or shoot an arrow or throw a stone, or club or other missile, at any animal or species within any private ground, public park, square, street or grounds, or take or destroy the eggs or young of any animal of any species within any private enclosure or public ground.

<u>SECTION II.</u> Any person, firm or corporation violating the terms of this Ordinance shall be fined not less than Fifty Dollars (\$50.00) nor more than Five Hundred Dollars (\$500.00).

<u>SECTION III.</u> This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet from as provided by law.
