ORDINANCE 96-07-01

AN ORDINANCE CREATING LAKES COMMISSION FOR THE VILLAGE OF THIRD LAKE

WHEREAS, the President and Board of Trustees of the Village of Third Lake have deemed it appropriate to create an advisory commission to the Village Board on the management of the lakes within the Village.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Third Lake, Lake County, Illinois, as follows:

SECTION 1: CREATION; PURPOSE.

There is hereby created a Lakes Commission for the Village. The Lakes Commission shall consist of seven (7) members who shall advise the Village Board on issues regarding the management of lakes within the Village.

SECTION 2: MEMBERS: APPOINTMENT AND TERM OF OFFICE.

- A. The Lakes Commission shall be comprised of seven (7) members who shall be known as Commissioners. The Commissioners shall be residents of the Village of Third Lake. The Commissioners shall be appointed by the Village President with the advice and consent of the Board of Trustees. One Commissioner shall be appointed Chairperson at the time of appointment and his or her designation as Chairperson shall expire April 1 of each year. If any Commissioner for any reason fails to complete his or her term, the Village President with the advice and consent of the Board of Trustees, shall appoint a replacement to fill his or her unexpired term.
- B. At all times there shall be one Commissioner who shall represent each one of the following lakes in the Village: Third Lake, Druce Lake, Fourth Lake. The Chairperson and three other Commissioners shall represent all lakes within the Village. At least one of these latter three Commissioners shall not live on any lake in the Village. If no representation of any one of the lakes and no representation from a non lake-front home owner can be obtained by the end of April of each year, then the Village President with the advice and consent of the Board of Trustees may accept the services of any resident in the Village to fill the Commission of seven members.
- C. The term of office for each Commissioner shall expire on April 1 of each year.

SECTION 3: ORGANIZATION.

The Village Clerk shall be responsible for preparing meeting agendas, taking minutes of meetings and other duties as prescribed by the Commission. They shall hold such meetings and establish such rules as they shall deem necessary and proper for the carrying out of their function. For meeting purposes, any four Commissioners shall constitute a quorum.

SECTION 4: DUTIES AND RESPONSIBILITIES:

- A. It shall be the duty of the Commissioners to advise the Village Board of Trustees on lake management issues. It shall be the duty of the Commissioners in making recommendations to the Village Board to take into account the needs of all residents of the Village. The final decision on all lake management issues rests with the Village Board.
- B. The Lakes Commission shall have the following specific duties and responsibilities:
 - 1. Serve in a citizens advisory capacity to the President and Village Board of Trustees;
 - 2. Recommend the need for public education programs, seminars, announcements and workshops and assist in their creation, planning and undertaking in conjunction with the Village and other outside agencies.
 - 3. Serve as a sounding board for citizen input, inquiry and needs as they relate to lake management;
 - 4. Recommend maintenance work as it relates to shore erosion, water quality, storm drainage, access upgrades and improvements;
 - 5. Recommend the need to contract for management services regarding aquatic weed control, fisheries evaluation and other special and general lake management needs;
 - 6. Recommend certain needs based on consultation with appropriate qualified advisors regarding wildlife control measures; upstream and downstream wetland and wildlife sanctuary maintenance techniques;
 - 7. Recommend budgetary needs for purchase of capital equipment, including consulting services specific to lake management and ongoing maintenance;
 - 8. Recommend changes and additions to lake use regulations, ordinances and community service officer involvement;
 - 9. Perform other activities involving lakes management as directed by the Village Board.

SECTION 5: This Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
