Rental Property Registration Form

Village of Third Lake Ordinance No. 10-06-05 requirements are as follows:

- All residential rental buildings are required to register.
- Owner must register the building with the Village within 30 days of building first being offered for rent.
- For buildings already in existence on the date of passage of this Ordinance, the building owner must register the building no later than 60 days from the date thereof.
- The registration must be renewed annually no later than May 1st of each year.
- Owner must certify that the information provided on the registration is true and correct.
- Owner must notify the Village within 20 days of any change in the registration information by filing an amended registration.
- Violation of any provisions of this Ordinance including submission of false information shall result in a fine of not less than fifty (\$50.00) nor more than seven hundred and fifty (\$750.00) dollars for each offense.
