## 5. Discussion

- A. Aquatic Plants Information: Chairman Lombardo is preparing a flyer to be handed out with this year's boat sticker including information about our lake's aquatic plants and also information on additional methods for residents to use to reduce aquatic plants around their pier and beach areas. Lake Weed Mats, Blades and Lake Rakes are a few of examples discussed. Concerning using chemicals to rid the lake of unwanted plants, President Buckley refreshed our memories about how the company that the village uses injects the chemicals into the bottom of the lake and the company that the homeowners used last year sprayed chemicals on top of the water which can and does spread to neighbors and out into the lake. Last year the homeowner's chemical company actually did spray past the property line and therefore on Village Lake property, the village did not pursue legal actions against company as in the end, the legal action would not be worth the village cost and effort.
- B. Father's Day Fishing Tournament: Todd Roesler reported on his efforts to gather prizes for the tournament, with Dicks Sporting Goods and BBQ Productions willing to help out. President Buckley stated that the ideas of this tournament is to get something happening for Druce Lake and added that small prizes and the cost of food the morning of event will be covered by the Village. Noted that no

fishing license will be required for tournament as the date falls on the states "free fishing weekend". Chairman Lombard stated that he also plans to add a flyer announcing the tournament and all the details to be handed out along with the boat stickers. Also plans to have it added to The Vine before April 1<sup>st</sup> when the boat stickers scheduled to go on sale.

- C. Flyer for Boat Sticker: Chairman Lombardo shared a flyer highlighting the Villages boating and lake rules that he suggests to be handed out with boat stickers. Also reminding us that an Aquatic Plants Information flier and a Father's Day Fishing Tournament flier will also be handed out along with the boat stickers. President Buckley reminded committee that boat stickers should be placed starboard, even though the sticker itself does not have directions on where to place. He also stated that per state law everyone born after 1998 is required to have a boat safety certification while operating watercraft; however, the village has no way of actually policing this law.
- D. Representative for Board Committee Meeting: Chairman Lombardo agreed to attend Board Committee Meeting.
