9. President Report

- President Buckley stated that a new restaurant (B&B) owner is moving into the Village has asked about liquor and gaming licenses. President Buckley asked the Board members for their opinions on adding more gaming. Several of the Trustees expressed concerns on oversaturation of gaming in the Village going forward. Trustees will wait to see the plans for this business and emphasized that they would like to see a sit-down restaurant with restaurant (and not gaming) as the primary business.
- We are looking to add a "Business Showcase" feature to the Village Vine, to highlight our local businesses each month. Village Attorney, Brian Baugh, stated that all businesses must be included, with no favoritism. The consensus was that the feature should be "commercial" free.
- President Buckley gave an update on Heidi's restaurant, now interested in both available suites at Grahams' Shell. Owner is currently working on a seating capacity plan.
- President Buckley let the Board members know that the building permits have been issued for Karma Sandwich and Wine Shop.
