Role of the Mayor/President (4 Year term)

- Represents the Village at all times
- Presides over all Board and Committee meetings
- Oversight of Village operations
- Coordination with outside agencies
- Oversight and management of the operating budget
- Responsible for the management of the Public Works Dept.
- Filling the role of Village Liquor Commissioner
- Available for Village emergencies outside of reg. business hrs.

Role of Trustee (4 Year term)

- Attend board and committee meetings (min. twice a month)
- Express opinions and solutions for Village happenings
- Special projects at the request of the President
- Vote on ordinances, budgets, and other village business
- Act as liaison with other entities
- May be asked to represent the Village in absence of the President
- Contact person for residents in the Village

# Fall Leaf Burning and Disposal

There are several ways to dispose of leaves this time of year. Composting, bagging or burning.


**Burning -** Dry leaves, brush, branches under 1 1/2" in diameter, and yard waste may be burned between November 1st and November 30th during the hours of 9AM and 3PM only.

- \* Burning is only allowed in a fireproof barrel or other receptacle that is elevated above ground by at least 6" but no more than 24"
- \* Burning is not permitted when wind is in excess of 15 mph, within 20' of any building or structure, within 25' of any wetland, lake or other body of water, or Lake County Forest Preserve property or on Village streets, sidewalks or other public right of way.
- \* Fire must be attended at all times by a person 16 years of age or older.
- \* Must have a water source and adequate means of delivering water immediately adjacent to the fire.

**Bagging** – Leaf stickers can be purchased at the Village Hall for \$1 during open business hours.
