B. Additional expense of \$42,000 payable to Aldridge to remove an additional 1,000 cubic yards of sediment from the dredging project in Mariner's Cove.

President Buckley explained that a resolution is needed to approve the above expense. He explained that the additional dredging is coming from the smaller pond.

C. Motion to approve a Change Order for \$55,000 payable to Aldridge to install 100' of storm sewer in small pond in Mariner's Cove

President Buckley explained that a resolution is needed to approve the above expense. He said that a culvert needs to be added between the two sections of the smaller pond because the steepness cannot be properly shored. He said the culvert will have ground over the top but will still be lower than the neighboring properties and road. The culvert will eliminate 200 ft of shoring and the HOA will reimburse the Village for 50% of the cost when they receive grant money for the shoring. President Buckley stated that he is waiting for more information and drawings from the engineer. The consensus of the Board is that this is a reasonable solution pending documentation from engineer.
