Our comprehensive service line includes case management, foster parent support and training, in home counseling, therapeutic mentoring and access to tele psychiatry to help create healthy environments of care. All services provided are designed to maintain children at the least restrictive, yet most appropriate level of care and to support youth in care of Department of Children and Family Services (DCFS) in foster homes. Camelot specializes in higher level foster care for children and adolescents that may need extra support. For that reason we partner with our foster parents to provide trauma informed care and additional services, including in-home counseling, tele-psychiatry and therapeutic mentoring. In the past the grant provided assistance with rental, food disparities, utility bill payments, and legal matters involving evictions. The NAACP also supports youth scholarships, ACT-SO Academic Competitions for High School students throughout the academic year. We are unique in that we serve the entire Lake County Community. The National NAACP was founded as an interracial civil rights organization to protect the rights and advance justice for African Americans on February 12, 1909. Our office in Third Lake supports health education.

Preparedness Month To be fully prepared for a disaster you need an emergency kit. That's the message for National Preparedness Month. Illinois Emergency Management Agency (IEMA) wants everyone to review their family emergency plans, fill out a family communications plan, and build an

emergency kit. It could be a matter of life or death because if you need to evacuate within minutes, you will need that kit packed and ready to go.

While some items recommended for an emergency kit seem obvious, like water and non-perishable food, others might not be immediately thought of during an urgent evacuation. Those items some families find critical in a disaster are; prescription and over-the-counter medicines, important documents like Social Security cards or insurance policies, cash, or personal care supplies like contact lenses and cleaners.

General preparedness items include:

- Water (one gallon per person per day for three days)
- Non-perishable food (three-day supply or ready-to-eat canned or other foods that require no refrigeration or cooking, non-electric can opener, utility knife)
- Flashlight with extra batteries
- First aid kit
- Battery-operated radio with extra batteries
- Extra battery/external charger for cell phone
- Copies of important family documents stored in a waterproof bag or container, cash
- Face coverings for all family members
- Hand sanitizer/disinfecting wipes

Lake County Forrest Preserve Controlled Burn Season

Each fall and spring, certified crews conduct controlled burns across hundreds of acres of preserves. Burns are the most cost effective tool for managing native plant communities. Without fire, invasive plants such as buckthorn, honeysuckle and other aggressive, non-native plants would grow out of control. Burn crews are comprised of professionals who received training from the U.S. Forest Service. If you're concerned about smoke coming from a forest preserve that may not be a controlled burn, please contact the Village Hall.

Fall Leaf Burning and Disposal

There are several ways to dispose of leaves this time of year. Composting, bagging or burning.

Burning - Dry leaves, brush, branches under 1 1/2" in diameter, and yard waste may be burned between November 1st and November 30th during the hours of 9AM and 3PM only.

- Burning is only allowed in a fireproof barrel or other receptacle that is elevated above ground by at least 6" but no more than 24"
- Burning is not permitted when wind is in excess of 15 mph, within 20' of any building or structure, within 25' of any wetland, lake or other body of water, or Lake County Forest Preserve property or on Village streets, sidewalks or other public right of
- Fire must be attended at all times by a person 16 years of age or older.
- Must have a water source and adequate means of delivering water immediately adjacent to the fire.

Bagging – Leaf stickers can be purchased at the Village Hall for \$1 during open business hours.
