THE DAM IS OPEN

Please be aware that the dam remains open throughout the winter. This can cause large fluctuations of water levels when we get a large amount of rain. We have continuous water movement so there will be areas of open water or very thin ice when we have ice. The dam gets closed on or around April 1st to allow the lakes to rise to their summer levels.

BOAT REGISTRATION

Both state registration and a Village sticker are required to boat on the lakes. In order to purchase a Village sticker, you must have a valid current state registration on file with the Village. If you are unsure of your state registration status, please call the Village Hall. If your sticker expired in 2022, please renew your state registration.

BOAT STICKER PREORDER

Boat stickers can be preordered for the 2023 boating season. Mail a check payable to the "Village of Third Lake" or contact village hall to pay with a credit card. Be sure to include a copy of the updated state registration and return address. The 2023 stickers will be available for delivery or pickup by April 1st, 2023. Stickers need to be purchased before boats and personal watercrafts are put in the lake.



Homes that are used as rental property must be registered with the Village each year. This registration is due by May 1st each year. There is no cost for this registration if completed on time or within 30 days of the property becoming a rental. There are no short-term rentals allowed. If you have any questions, you may contact the Village Hall.

Through Project ACT, the Illinois Department of Public Health is distributing up to one million at home antigen tests to 200,000 Illinois households.

ICE SAFETY

The Village would like to urge all parents to remind their children to stay away from ice on the ponds and lakes. It only takes a few seconds for a moment of harmless play to turn tragic. It is important to understand that even though the ice may look strong and safe, if the water under the ice is moving, the ice may not form evenly and appear sound in one place while being weak nearby. With the fluctuations in temperatures, ice thickness is not always consistent and can change dramatically daily.
