- 9. President Report President Buckley reported that Karma has passed building inspections and is waiting to Lake County Health Dept inspections. He said that they do not have gaming license yet.

- 12. Committee Reports
 - A. Finance President Buckley stated that the Board will be working on budget next month. He said that there are still some items needed to add to budget. Pres.
