# AN ORDINANCE ESTABLISHING A ZONING FEE SCHEDULE AND REPEALING ORDINANCE NO. 21-03-01

BE IT ORDAINED by the President and Board of Trustees of the Village of Third Lake, Lake County, Illinois as follows:

#### **SECTION ONE:**

An owner of property, or agent thereof, submitting any application or petition to the Village seeking one or more of the following elements of relief, from or by the Village, shall pay to the Village as part of such application or petition a fee for each such element of relief, as outlined in Exhibit A:

In addition to the fees in Exhibit A, an applicant shall be responsible for all costs of required public notices and for all other costs required to be paid or reimbursed to the Village pursuant to the applicable reimbursement of fees agreement.

#### **SECTION TWO:**

Ordinance Nos. 90-12-01, 95-12-01, 97-01-02, 98-12-02, 03-10-0, 11-12-01 and 21-03-01 are repealed in their entirety. In addition, all other ordinances and resolutions, or parts thereof, in conflict with the provisions of this Ordinance are, to the extent of such conflict, hereby repealed.

#### **SECTION THREE:**

This Ordinance shall be in full force and effect from and after its passage, approval and publication as required by law.
