4. Open to the floor – Jeff Gibson addressed the Board regarding a massage business that he would like to open in Waterstone Shopping Center. He stated that he has opened 5 massage stores in the past. He currently owns two in the area, one in Deer Park and the other in Fox River Grove. He would like the current location to have 4 rooms and 2 employees to start. The business would be open 7 days a week and the hours would be from 10 a.m. to 9 p.m. He stated that he has other investors that would run the daily operations. He explained that none of his locations ever had problems with "bad" massages or problems with law enforcement.

- 9. Mayor Report -
 - A. Mayor Buckley said that Municode is still working on the final draft and should be available by the end of August.
 - B. Mayor Buckley stated that the Village will be interviewing for an administrative assistant and that temporary help has been hired on an as needed basis. Mayor Buckley asked Trustee Mateja to help with the interview process.
 - C. Mayor Buckley stated that the website needs to be updated. He explained that he was approached by a resident whose daughter may be able to make some updates. Mayor Buckley asked for some suggestions from Trustees for the website.

- E. Public Works Mayor Buckley stated that the grass is starting to grow in the park area. He said that he would like to poll the residents for a name for the park. He explained that the park will be grass only and not a tot lot, beach or marina as rumored.

Mayor Buckley stated that the massage business that wants to open in Waterstone will need a Planning and Zoning hearing, but since the current zoning does not indicate massage businesses, an additional ordinance changing the zoning will have to be passed before a special use permit can be passed.
