Mayor Buckley explained that there will be 4 easement agreements in total for the storm sewer that will be replaced. He explained that IDOT will replace the private storm sewer in conjunction with the widening of Hwy 45.

A, Mayor Buckley stated that the P & Z committee is working on the zoning rewrite. The next meeting will be in March.

PUBLIC WORKS

A. Mayor Buckley stated that the Lake Ave project is going out to bid this week and is being handled by the engineering firm. The bid openings will take place the day of the board meeting, but it will not be voted on at the meeting. Mayor Buckley explained that the bid will help determine the amount that will be put into the budget. Mayor Buckley said that the current width of the road varies and the new road will be 24 ft wide. He stated that he is still working with ComEd about putting utilities below ground. The current plan includes village hall parking lot, cul de saq at the end of N Lake, all of N Lake Ave to Sunshine, moving the storm sewer on S Lake Ave to the fire lane and off private property.
