### BUSINESS LICENSE FEE CALCULATIONS

License fees under the terms of this Ordinance for the businesses located in CB and GB Zoning shall be set forth as fifty dollars (\$50) per category as follows:

- B3. Auto, motorcycle, watercraft (new or used) sales
- B4. Barber shops and salons, spas
- B5. Bankers, Brokers, Management, Insurance and Real estate
- B6. Breweries, Distilleries and Bars
- B7. Convenience store
- B8. Drycleaners
- B9. Florist and plant shops
- B10. Food establishments  
Bakeries, Candy, Confectionery stores, Catering services, Coffee houses, Delicatessens,  
Fish markets, Grocery, Ice cream and Restaurants.
- B11. Fuel Station
- B12. Service station (auto, boat, cycle)
- B13. General Retail
- B14. General Service
- B15. Hospital
- B16. Hotel, Motel
